## 4 MILE SNOWSHOE RACE/WALK

This snowshoe event is named in honor of Albert "Curly" Voll who ski raced the trails you will be snowshoeing on. As a youngin' in 1944 he raced down the Shadow Trail in a record time of 1 minute and 12 seconds (which still stands today). So far no one beat his time on snowshoes – Come try to do so this year!

- COURSE:** 4 MILES – 1024' OF CLIMB / DESCENT. A ROLLING MIX OF UNBROKEN SINGLE-TRACK AND OLD SKI TRAILS FROM THE EARLY YEARS OF SKI RACING IN BERKSHIRE COUNTY.
